STANDARD LONG DISTANCE VISITATION SCHEDULE

The non-custodial parent shall have visitation with the minor child(ren) of the parties as follows:

ELECTION NOT TO EXERCISE

In the event the non-custodial parent elects not to exercise a particular period of Holiday Visitation as approved by the Court, the non-custodial parent shall give the custodial parent fourteen (14) days advanced written notice of the non-custodial parent's intent not to exercise such visitation period.

OUT-OF-STATE VISITATION

The non-custodial parent shall be entitled to remove the minor child(ren) from the home state of the custodial parent to exercise visitation, subject to the conditions set forth herein.

ADDITIONAL VISITATION

The non-custodial parent shall be entitled to additional visitation within the home state of the custodial parent for periods not to exceed five (5) consecutive days at any reasonable time and place with prior notice to the custodial parent, EXCEPT:

- a. The non-custodial parent may not exercise in-state visitation on the birthday of the custodial parent or on Mother's Day or Father's Day (whichever is applicable to the custodial parent);
- b. The non-custodial parent may not exercise in-state visitation on the child's birthday on odd numbered years (i.e. 2025, 2027, etc.);
- c. The non-custodial parent may exercise in-state visitation on only one of the following holidays per calendar year: Easter, Memorial Day, and Labor Day; and
- d. The child(ren) is/are required to attend all regularly scheduled pre-school and school classes during the in-state visitation.

The request for in-state visitation shall be made by the non-custodial parent at least seven (7) days before the first day of the requested in-state visitation. All requests for visitation shall be made in writing to the last address of the custodial parent as shown in the court file, or such other address as the custodial parent has provided subsequently in writing. The request shall designate the time and date of the pickup of the child(ren) and the time and date of re-delivery of the child(ren) (but in no event exceeding five (5) days or a total of one hundred twenty (120) hours). All pick up and delivery of the child(ren) shall occur between 7:00am and 10:0pm.

The non-custodial parent may obtain additional out-of-state visitation upon obtaining prior consent of the custodial parent, which consent shall be in writing and shall designate the time and date of pick up and re-delivery of the child(ren).

TRANSPORTATION

The parties shall share the obligation and responsibility for transporting the child(ren) for the exercise of visitation by the non-custodial parent. Each party shall have the right to transport the child(ren) for visitation by either ground or air. At least thirty (30) days prior to a scheduled visitation, the parties are to mutually arrange for the transportation of the child(ren) for the visitation. In the event the parties cannot agree on the mode of transportation, then each party shall have the right to transport the child(ren) by either air or ground.

If air transportation is elected by both parties, they shall each pay their respective proportionate percentage (based on the child support guideline calculations) of the ticketed travel expense at the time of the purchase of the airline ticket. In the event one party elects to fly the child(ren) and the other elects to transport by ground, each party shall be responsible for the entire cost of their chosen mode of transportation. In the event the parties elect to use ground transportation for the scheduled visitation, then the parties are to meet at a halfway point between the residence of the respective parties.

In the event air transportation is chosen by a party, that party has the responsibility to ensure that young children are accompanied by a responsible adult or make arrangements with the airline for

the supervision of the unaccompanied minors. Each party shall have the right to select the commercial airport from which he/she will send and/or receive the child(ren); and each party shall provide transportation for the child(ren) to and from the airport he/she has selected.

EMERGENCY

In the event of any emergency involving a minor child's health or welfare, the parent in possession of the child shall promptly notify the other parent and either parent may visit the minor child, without giving notice to the other parent, at reasonable times and places under the circumstances. In the event of any injury to the child involving a doctor's appointment or hospitalization, the parent in possession of the child shall immediately notify the other parent within six (6) hours.

TELEPHONE

Liberal telephone communications between each parent and the child(ren) is encouraged and shall be allowed.
